Pike County District Attorney Ray Tonkin announced the following criminal sentences were issued by Pike County President Judge Joseph F. Kameen:

Omar Pienkiewicz, age 35, of New Hampton, NY was sentenced to 24 months of probation and ordered to pay a fine of \$ 500.00 for the crime of Access Device Fraud. On May 5, and 6, 2011, Pienkiewicz used another persons' credit card to purchase merchandise in Matamoras Borough without their permission.

Natasha Stojanovski, age 23, of Dingmans Ferry, PA was sentenced to 12 months of probation and ordered to pay a fine of \$ 200.00 for the crime of Theft by Unlawful Taking. In March 2012, in Dingman Township, Stojanovski took an engagement and wedding ring from another person.

David Ross, age 31, of Milford, Pa was sentenced to 6 months of probation and ordered to pay a fine of \$ 525.00 for the crime of Driving Under the Influence and two motor vehicle code violations. On June 6, 2012, in Dingman Township, Ross was found to be driving under the influence and without a valid driver's license. His blood alcohol level was .098%.

Clarence Moor-Burvick, age 22, of Lords Valley, PA was sentenced to 12 months of probation and ordered to pay a fine of \$ 200.00 for the crime of Retail Theft. On November 8, 2012, Moore Burvick took numerous assorted items without paying the full retail value of \$ 699.29 in Westfall Township.

Frank Zrillo, age 33, of Bushkill, PA was sentenced to the Pike County Correctional Facility for 33 to 67 days for the crimes of Disorderly Conduct and Criminal Mischief. On October 29, 2012, in Lehman Township, Zrillo kicked and punched another persons' vehicle causing damage.

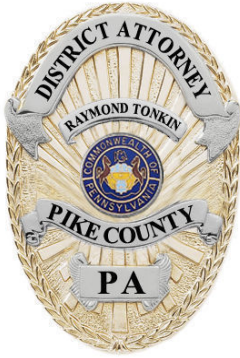

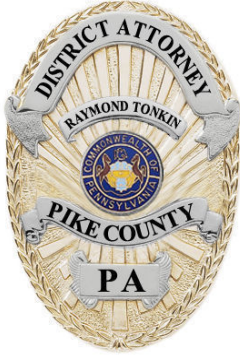

Pike County District Attorney Ray Tonkin announced the following criminal sentences were issued by Pike County President Judge Joseph F. Kameen:

Joshua Seidel, age 19, of Port Jervis, NY was sentenced to a State Correctional Facility for 12 to 24 months and ordered to pay a fine of \$ 400.00 for the crime of Theft by Unlawful Taking. On February 1, 2012, in Westfall Township, Seidel took a Toshiba computer from one person and then tried to sell the computer to another. While attempting to sell the computer, Seidel stole \$ 200.00.

Jennifer Ficker, age 38, of Milford, PA was sentenced to the Intermediate Punishment Program for 30 days followed by an additional 90 days of electronic alcohol detection monitoring, ordered to pay a fine of \$ 1,500.00 and had her driver's license suspended for 18 months for the crime of Driving Under the Influence. On April 8, 2012, in Dingman Township, Ficker drove her vehicle off the road striking a boulder and refused to submit to a chemical test to determine the amount of alcohol on her breath.

Christine Babcock, age 33, of Dingmans Ferry, PA was sentenced to the Pike County Correctional Facility for 48 hours to 6 months, ordered to pay a fine of \$ 1,000.00 and had her driver's license suspended for 1 year for the crime of Driving Under the Influence. Pike County District Attorney Ray Tonkin announced the following criminal sentences were issued by Pike County President Judge Joseph F. Kameen:

Paul Dzyak, age 31, of Milford, PA was sentenced to the Pike County Correctional Facility for 72 hours to 6 months, ordered to pay fine of \$ 1,000.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence. On May 20, 2012, in Delaware Township, Dzyak was found be driving under the influence. His blood alcohol level was .217%.

Lisa Crass, age 50, of Dalton, PA was sentenced to a State Correctional Facility for 20 months to 4 years, and ordered to pay a fine of \$ 600.00 for the crime of Burglary. In June 2012, Crass entered a business in Milford Township and took various items including jewelry, a surveillance system, sales tax records, U.S. Currency, a framed picture and a Louis Vutton box.

Carmen Patti, age 47, of Hamburg, NJ was sentenced to the Pike County Correctional Facility for 7 to 23 months followed by an additional 2 years of probation and ordered to pay a fine of \$ 2,000.00 for the crimes of Theft by Unlawful Taking, and False Reports. In August 2011, Patti furnished false information to the Pennsylvania State Police by implicating another person of burglary.

On July 23, 2012, in Lehman Township, Rich pushed and struck another person and then damaged the interior walls and telephone of the residence.

Teline Cole, age 40, of Matamoras, PA was sentenced to a State Correctional Facility for 2 to 10 years, ordered to pay a fine of \$ 800.00 and had his driver's license suspended for 12 months for the crime of Delivery of a Controlled Substance. On four separate occasions Cole sold marihuana to an undercover police officer in Matamoras Borough. On November 1, 2011, Cole delivered 3 bags of marihuana to an undercover police officer for \$ 60.00. On November 14, 2011, Cole delivered 5 bags of marihuana to an undercover police officer for \$ 100.00. On November 23, 2011 Cole delivered 4 bags of marihuana to an undercover police officer for \$ 80.00. On December 14, 2011 Cole delivered 5 bags of marihuana to an undercover police officer for \$ 100.00.

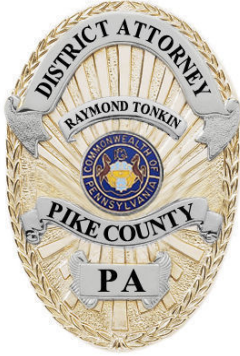

Pike County District Attorney Ray Tonkin announced the following criminal sentences were issued by Pike County President Judge Joseph F. Kameen:

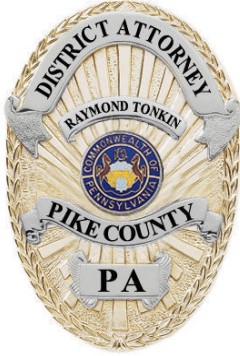

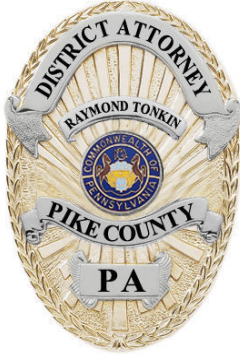

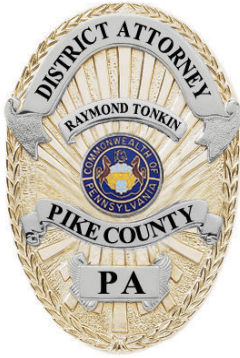
Pike County District Attorney Ray Tonkin announced the following criminal sentences were issued by Pike County President Judge Joseph F. Kameen:

Pike County District Attorney Ray Tonkin announced the following criminal sentences were issued by Pike County President Judge Joseph F. Kameen:

Darrell Lavoie, age 24, of Tafton, PA was sentenced to the Pike County Correctional Facility for 48 hours to 6 months, ordered to pay a fine of \$ 1,000.00 and had his driver's license suspended for 12 months for the crime of Driving Under the Influence. On June 17, 2012, in Palmyra Township, Lavoie was found to be driving under the influence of alcohol. His blood alcohol level was .152%.

Samuel Slatas, age 75, of Clifton, NJ was sentenced to a State Correctional Facility for 6 to 24 months and ordered to pay a fine of \$ 500.00 for the crime of Theft by Failure to Make Required Disposition of Funds. In Palmyra Township, between April and May 2011, Slatas obtained U.S. Currency from another person to invest in to an interest bearing CD, but instead Slatas used the money as his own.

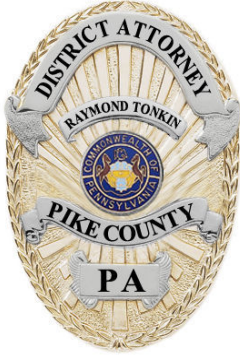

Sean Mahon, age 32 of Canadensis, PA was sentenced to the Pike County Correctional Facility for 6 months and 3 days to 23 ½ month, ordered to pay a fine of \$1,500.00 and had his driver's license suspended for 2 years for the crimes of Driving Under the Influence and Possession of a Controlled Substance. On September 11, 2012 in Greene Township, Mahon was found to be driving under the influence. He was found be driving under the influence and marihuana and also was in possession of a small amount.

Mitchell Griffin, age 19, of Enyon, PA was sentenced to a State Correctional Facility for 4 years and 5 months to 11 years, and ordered to pay a fine of \$ 500.00 for the crime of Robbery. On October 10, 2012, Griffin and his co-defendant entered a business in Milford Borough and demanded money with a box cutter.

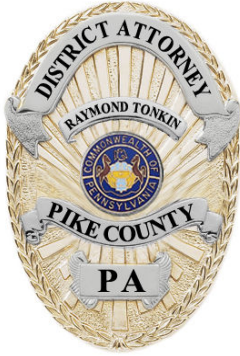

Pike County District Attorney Ray Tonkin announced the following criminal sentences were issued by Pike County President Judge Joseph F. Kameen:

William Jamros, age 19, of Matamoras, PA was sentenced to 12 months of probation and ordered to pay a fine of \$ 250.00 for the crime of Simple Assault. On September 1, 2012, in Matamoras Borough, Jamros put another person in fear of serious bodily injury by threatening them.

Robert Treat, age 70, of Bushkill, PA was sentenced to a State Correctional Facility for 11 months to 8 years, and ordered to pay a fine of \$ 1,500.00 for the crimes of Sexual Abuse of Children (Possession of Child Pornography) and Criminal Use of a Communication Facility. Treat was also ordered to refrain from using any device that connects to the internet, having any contact with children unless supervised and register under Pennsylvania Megan's law for 15 years. Treat was found in possession of two computers containing numerous images of children under the age of 18 engaging in sexual acts such as sexual intercourse, oral sex and masturbation in Lehman Township.

David Sisco, age 26, of Milford, PA was sentenced to the Pike County Correctional Facility for 4 to 23 ½ months followed by an additional 12 months of probation, ordered to pay a fine of \$ 1,000.00 and had his driver's license suspended for 6 months for the crime of Attempt to Acquire Acquisition of a Controlled Substance by Fraud. On March 19, 2012, Sisco presented a fraudulent prescription to a pharmacy in Westfall Township in an attempt to obtain Oxycodone.

Joshua Clemens, age 23, of Canadensis, PA was sentenced to a State Correctional Facility for 2 ½ to 6 years, ordered to pay a fine of \$ 500.00 and had his driver's license suspended for 18 months for the crimes of Delivery of a Controlled

On July 21, 2012, Dimeo was found to be driving under the influence in Westfall Township. He refused to submit to a chemical test to determine his blood alcohol content. In a separate incident on September 20, 2012, Dimeo was in possession of 1.6 grams of heroin, 76 Alprazolam pills, cocaine, and marihuana in Dingman Township.

Gregory Smith, age 49, of Greentown, PA was sentenced to the Pike County Correctional Facility for 1 to 5 years, ordered to pay a fine of \$ 2,700.00 and had his driver's license suspended for 18 months for the crime of Driving Under the Influence and Driving While Operating Privileges are Suspended. On September 2, 2012, Smith was found to be driving under the influence and without a valid driver's license. Smith refused to submit to a chemical test to determine his blood alcohol content.

Richard Ramirez, age 33, of Newton, NJ, was sentenced to a State Correctional Facility for 18 to 36 months, and ordered to pay a fine of \$ 1,300.00 for the crimes of Criminal Trespass and Institutional Vandalism. On November 11, 2012 in Dingman Township, Ramirez pried open a garage door to gain entry in to a residence knowing his was not privileged to enter. Ramirez then kicked the windshield and banged his head on the passenger side window of a Pennsylvania State Patrol vehicle causing damage.

William Sullivan, age 23, of Greentown, PA was sentenced to a State Correctional Facility for 7 to 15 years, and ordered to pay a fine of \$ 1,000.00 for the crime of Robbery. On July 29, 2012, Sullivan entered a convenience store in Greene Township, brandished a replica firearm and demanded money and cigarettes from the two clerks. In a separate incident on August 5, 2012, in Greene Township, Sullivan robbed two people threatening them demanding their money and property.
